- II. Paul called the regular meeting of the Crystal Bay Town Board to order at 7:00 pm with the Pledge of allegiance.

 - B. Hockhaman Creek Road Work:
 - 1. The Snowmobile club asks if there is any additional liability for using the ATV trail as the bypass for the bridge construction project. Colby will check with MAT for any guidance.

- VI. New Business
 - A. Silver Bay Airport: Chris(via phone) with Bawlig Engineering Wilmer MN
 - 1. Silver Bay is looking at operating the airport in the black which only happens when it is being supported, potentially by public support.

The intention is to ask IRRRB to cover the 5% of expenses not covered by Federal and State funds to reopen the airport. Best case scenario no cost to Crystal Bay as costs are covered by operations, this would take significant work. Worst case scenario based on past performance \$1/yr/taxpayer. The other nearby airports are Two Harbors, Grand Marais, Ely, Hibbing who have waiting lists for hanger space so there is full anticipation of filling our hangers if we open. Chris is uncertain on which fire fighting planes would be able to utilize the renovated airport. If the airport is not kept as an airport the FAA would expect some of the proceeds of the sale back to cover investments they made. Silver Bay is looking for support maintaining and managing the Airport.
